Applications on the prescribed forms are invited for admission to **B.A./B.Com. PART-I** Course for the academic session 2011-12 through distance mode of the Directorate of Distance Education, University of Jammu and its Study Centres, Government Degree College at Kathua/Udhampur/Poonch/Rajouri/Doda/Bhaderwah/Kishtwar as per the following schedule:-

a) Sale & Submission of Application

forms without late Fee = 28-07-11 to 17-08-11

b) With late fee of Rs. 150/- = 18-08-11 to 24-08-11

c) With late fee of Rs. 290/- = 25-08-11 to 31-08-11

The Vice-Chancellor may consider grant of late admission for one month only after the expiry of last date on payment of Rs. 1480/- subject to the condition that the monthly income of the candidate's parents below Rs. 3300/-. He/She be exempted from payment of Rs. 1480/-. However, late fee shall be charged in such cases as prescribed at (c) above.

No admission will be granted after 30th of Sept, 2011.

Eligibility Conditions:

A candidate must have passed 10+2 examination or an equivalent examination from J&K Board of School Education or from any recognized Board/University or a candidate having reappear in one subject in 10+2 examination in the relevant stream is also eligible to seek admission in B.A./B.Com. Part-I. A Candidate who has passed 10+2 examination in a stream other than Commerce with 45% marks or more is also eligible to seek admission in B.Com. Part-I.

The Prospectus-cum-Application forms can be obtained from the Directorate of Distance Education or its Study Centres on payment of Rs. 110/-. Admission forms are also available on our website: www.distanceeducationju.in. Candidates who downloaded the forms from our website are advised to include Rs. 110/- as cost of prospectus in the admission fee.
