Total marks in Theory		
ii) <u>Marks obtained in Teaching Practice</u>	X	20
Total marks in TP		
Total (i) + (ii)	=	

For example :- Total marks of theory 700, marks obtained in theory 350

$$\text{i) } \frac{350}{700} \times 80 = 40.00$$

Plus

$$\text{ii) } \frac{210}{300} \times 20 = 14.00$$

$$\text{Total merit points} = 54.00$$

- b) All the candidates shall bring crossed demand draft of any bank of Rs.10,060/- drawn in favour of Director, Directorate of Distance Education, University of Jammu, Jammu payable at Jammu along with all requisite documents in original at the time of counselling, failing which their counseling shall not be conducted

- e) If any candidate remains absent for counselling on his/her turn as per the merit, he/she shall be considered for admission on the subsequent days of counselling subject to the availability of seats.
