B.ED. ADMISSION NOTIFICATION 2019-21

Online applications on prescribed format are invited from eligible candidates for admission to the B.Ed. programme through distance mode for academic session 2019-21. Application forms will be available on website www.distanceeducationju.in from 25-07-2019 along with detailed information about the admission process.

Eligibility: Candidates fulfilling the following conditions shall be eligible to seek admission to the B.Ed. programme

- i) who have passed Bachelor's Degree Examination (10+2+3) with 45% aggregate marks for General Category and 40% marks for the reserved categories of SC/ST and others (as per the rules of the State Govt/reservation policy of the University of Jammu) in the faculty of Arts, Science, Social Sciences, Commerce or the faculty of Music and Fine arts conducted by the University of Jammu or an examination from any other university organized as equivalent thereto. It needs to be mentioned that all those in-service teachers who shall be deputed by the School Education Department shall be exempted from the %age criteria in the qualifying examination. They shall be deputed by their parent department on the basis of the seniority determined by the School Education Department.
- ii) who are serving as full time teachers in recognized schools (Primary, Elementary, Secondary, Higher Secondary levels) within the territorial jurisdiction of the University of Jammu.
- iii) who have a minimum of two years teaching experience either at a stretch or in parts at the time of submission of the application form for admission.
- iv) First preference will be given to the candidates who have completed Diploma in Education/Diploma in Elementary Education/ who are trained in-service teachers in Elementary Education.

Applicants are advised to fill in the form ONLINE with correct particulars and take out the print out of the filled in form for the personal record and for further use for the counseling-cum-admission. After filling in the Application Form online, candidate needs to make the payments of Application Fee online only. Please check the exact amount of Application Fee to be paid through online mode using any bank debit card/credit card/internet banking.
